WHEREAS, the United States Professors of the Year program, sponsored by The Carnegie Foundation for the Advancement of Teaching and the Council for Advancement and Support of Education, is a national program for recognizing excellent undergraduate teaching; and

WHEREAS, the criteria for selection includes extraordinary dedication to undergraduate teaching, demonstrated by excellence and involvement with undergraduate students; scholarly approach to teaching and learning; contribution to undergraduate education in the institution, community, and profession; and support from colleagues, as well as current and former students; and

WHEREAS, Professor Hamman has been named as the 2012 Carnegie Foundation for the Advancement of Teaching Maryland Professor of the Year from a nationally competitive pool of outstanding community college and university educators; and

**AMENDMENT TO SOLE SOURCE AWARD OF CONTRACT,
COURSE SCHEDULING ASSISTANT SOFTWARE**

BACKGROUND

In 1999, the Maryland Higher Education Commission (MHEC) and the community college presidents collaborated to award a grant for the creation of a web-based system to help individuals and businesses search and locate continuing education offerings at all 16 Maryland community colleges. With the support of the Maryland Association of Community Colleges, several community colleges, including Montgomery College, were granted a license in 2001 for the use of Symplicity Networks, Inc., software CRS-2e000.

In June 2003, the Board of Trustees approved the sole source purchase of the Symplicity Networks' CRS-2e000 web-based course search software in the amount of \$187,680. Subsequently, in June 2006 and 2007, the Board approved amendments to the contract with Symplicity Networks to purchase additional modifications to the course scheduling software modules and development services in order to meet programmatic needs and annual maintenance services. These additional costs totaled \$80,000.

In an effort to improve system processes associated with the existing CRS-2e000 web-based course search software system, the vice president of Workforce Development & Continuing Education (WD&CE) has requested amending the current agreement for additional software development and modifications to the system in order to aid in the creation of a relational database that can produce special reports and course information such as the MHEC CC-10 funding documents, courses/section development at the program level, related web pages for those courses/sections, and website and document design for a total cost of \$70,000. This additional cost raises the total annual cost for programmatic and maintenance services to \$150,000. While the need for system process improvements existed last spring, other competing time sensitive projects such as several building remodeling efforts, and new program initiatives took precedent. Funding for this purchase has been requested in the FY13 WD&CE operating budget. Board approval is required for sole source procurements valued above \$100,000.

Subject: Amendment to Sole Source Award of Contract, Course Scheduling Assistant Software

WHEREAS, in 1999, the Maryland Higher Education Commission (MHEC) and the community college presidents awarded a grant to create a web-based system to assist individuals and businesses search and locate continuing education offerings at the 16 Maryland community colleges; and

WHEREAS, in 2001, the College was granted a license for the use of Symplicity Networks, Inc., software CRS-2e000; and

WHEREAS, in 2003, the Board of Trustees awarded a contract for the purchase of web-based course search software CRS-2e000, to Symplicity Networks, Inc., of Washington, DC, on a sole source basis; and

WHEREAS, in 2006 and 2007, the Board of Trustees approved amendments to the contract with Symplicity Networks, Inc., to purchase additional modifications to the course scheduling software modules and development services in order to meet programmatic needs and annual maintenance services; and

WHEREAS, the vice president of Workforce Development & Continuing Education (WD&CE) has requested amending the current agreement for additional software development and modifications to the system to aid in creating a relational database that produces special reports and course information; and

WHEREAS, the acting director of procurement affirms that the sole source request is justified since the product is not available through any other source; is proprietary; and is currently the only product that will meet the College's needs; and the interim vice president of finance/chief financial officer certifies that funds have been requested and are available in the FY13 WD&CE operating budget; and

WHEREAS, College policy states that the formal bidding process may be dispensed with in the event of a sole source procurement and modifications to contract values; and

WHEREAS, the president of the College recommends the following action; now therefore be it

Resolved, That the Board of Trustees approves the amendment to the contract for the purchase of additional development services of the course scheduling software on a sole source basis to Intelligent Design Solutions (doing business as Symplicity Networks, Inc.), which is located in Washington, DC, for a not-to-exceed amount of \$150,000.

RETIREMENT OF POLICY 44001–FUNDING OF ATHLETICS AND STUDENT LIFE

BACKGROUND

Montgomery College is committed to sound fiscal management and responsible stewardship. The student life and athletics budgets are supported by the College through the consolidated fee, which is charged and collected at the time of student registration. The amount of the consolidated fee apportioned to student life and athletics is established by the Board of Trustees, upon the recommendation of the president, as part of its action each year on the College's operating budget.

All monies collected through the consolidated fee and expended for student life and athletics are subject to budget review and are thereby subject to oversight by the Board, and implementation by the president or designee. The College has recently undergone a One College reorganization effort aimed at streamlining and consolidating athletics and student life. To that end, the president has designated the senior vice president for student services as the lead administrator responsible for developing and administering student life and athletics budgets.

Our current policy on athletics funding and student life was developed during a time when the College acted as three campuses instead of one college. Now that the College has one athletics program, this policy is no longer relevant, and it is requested that it be retired.

RECOMMENDATION

It is recommended that the Board of Trustees retire Policy 44001–Funding of Athletics and Student Life.
